Huber moved to approve the January regular meeting minutes as presented. Bierlein supported. Motion carried.

Sandy Schian, chief curator of Castle Museum, promoted the Chronicling our Past project and requested use of a space within the Township later this year.

Roethlisberger moved to approve the 2023 Hardship Property Tax Reduction Guidelines. Daenzer supported. Motion carried.

Roethlisberger moved to set the mileage rate at the IRS rate of \$0.65.5. Daenzer supported. Motion carried.

Roethlisberger moved to set the hourly wage for Deputies for 2023/2024 at \$16.00/hours. Daenzer supported. Motion carried.

Roethlisberger moved to set the Treasurer's salary for 2023/2024 at \$20,292.00, plus \$850 for Summer Tax collection. Bierlein supported. Motion carried 4-0, Daenzer abstained.

Roethlisberger moved to set the Supervisor's salary for 2023/2024 at \$12,708.00. Bierlein supported. Motion carried 4-0, Reinbold abstained.

Daenzer moved set the Clerk's salary for 2023/2024 at \$20,292.00 plus \$2,400 per election. Bierlein supported. Motion carried 4-0, Roethlisberger abstained.

Bierlein moved to approve presented check register 26767 - 26791, payroll, and monthly EFT's. Huber supported. Motion carried.
